POLICIES

CLIENT UPDATES: To provide the best care for your pets, we need to keep all information on file current. We encourage our clients to contact us in a timely manner with any changes (i.e. telephone #, feeding instructions, adding a new pet, medication, keys, veterinarian changes, and/or emergency numbers).

RETURNED CHECK FEE: \$35.00

EXTENDING YOUR STAY: We understand travel plans occasionally change at the last minute. However, we schedule incoming guest availability according to our outgoing guests. Any pets staying beyond their pre-scheduled checkout date WITHOUT NOTIFYING US IN ADVANCE may be subject to a \$25.00 surcharge per day.

FEEDINGS: We feed at approximately 6:00 AM, 12:00 PM and 6:00 PM. Please feed your pet at home if you check-in after 6:00 p.m. We serve Zignature for an additional \$2.00 per meal. If you bring your pet's food from home, please package dry kibble in individual servings (such as in Baggies or Ziploc bags) and label the same with the dog's first and last name. Large containers, bags or bins of food should only be brought for dog's staying longer than 1 week.

CHECKING-IN: All boarding dogs must be in house by 3:00PM Monday through Friday and by 11:00AM Saturday and Sunday. This is requested in order to ensure your dog has some time play and get acclimated before bed-time. We recommend dropping off as early in the day as possible so your dog has a chance to take advantage of daycare and drain some energy before they hit their den for the evening routine.

CHECKING-OUT: Anytime during our normal business hours. After hours, a late check-out fee will be assessed. This can be waived if your dog is booked for a bath. We highly recommend they get a bath before pickup.

DAYCARE LATE FEE: Daycare dogs picked up after closing will be charged \$1, for every minute past closing (7:00 PM). Any dog not picked up 20 minutes after closing will be required to board overnight with additional boarding/meal charges made responsible to the owner.

FLEA & TICK PREVENTION: We require flea and tick prevention for all pets. If your pet is not on a preventative at the time of boarding, we will, at your request, provide Frontline for a minimal fee.

PERSONAL POSSESSIONS: Please label all of your dog's personal belongings. You are welcome to bring a toy, nyla bone (no rawhides or baked bones), treats and your pet's favorite bedding to make their stay more enjoyable. However, we cannot be responsible for the condition of these possessions during your pet's vacation. Soiled, wet or dirty bedding will be removed, bagged and our bedding will be provided at no charge.

HEALTH: Pets having symptoms of diarrhea, vomiting, coughing and/or sneezing should not be brought to camp. These symptoms may be easily spread to other customers. If your pet has any of these please contact your veterinarian for treatment and keep your pet at home until he/she is feeling better.

ENTERING/EXITING SAFETY: For safety reasons all guests must be on leash or in a carrier while entering and departing our lobby. Dog interaction is not recommended between dogs on leash while in our lobby. We will properly introduce all dogs in our assigned off-leash areas

FOUR PAWS RELEASE AND WAIVER

At 4Paws K9 Training, LLC and its affiliates (aka Four Paws) ("Four Paws"), we strive to provide a safe, social and stimulating environment for your dog during its stay. While dogs are playing together, they run the risk of certain injuries such as scratches, cuts and sprained joints. Such injuries are rare, but do happen at all doggy daycares. At Four Paws, we have procedures to screen all dogs for behavior that are unfit for daycare or boarding. While we love all dogs, for their safety, we do not intake dogs that exhibit aggressive or overly anxious behaviors. However, even the friendliest of dogs can get into fights with other friendly dogs with very little or no warning. In addition to injuries, it is possible for dogs to transfer illnesses such as diarrhea or canine cough, even with all required vaccinations and boosters. We take the health of your dogs seriously, and all dogs must have the necessary vaccinations prior to check-in. I have read and understand the following:

1. I understand that there are inherent and potential risks involved with interactions between humans and dogs, as well as between dogs and other dogs. I fully accept and assume all such risks. Except to the extent caused by Four Paws' gross negligence or intentional misconduct, I acknowledge that Four Paws will not be liable for any claims of injury, illness, damage or death to my dog during its stay. Under no circumstances will Four Paws be liable for consequential damages. 2. I certify that all information disclosed in the registration form is complete and accurate. I have informed and shall continue to inform Four Paws on an ongoing basis any and all medical and behavioral condition. I agree to hold harmless and indemnify Four Paws from and against all claims, damages, losses and expenses incurred by Four Paws arising out of or resulting from the actions of my dog during its stay at Four Paws. 3. If Four Paws determines in its sole discretion that my dog is unhealthy, undisciplined, aggressive, or exhibit behavior that may otherwise be considered dangerous to itself or others, Four Paws has the right to refuse or rescind services and may kennel my dog for the duration of its stay. Four Paws may refuse or rescind services if it determines that a customer behaves rudely or is otherwise disruptive to its operations. 4. I will not hold Four Paws liable or responsible for any loss or damage to any of my personal belongings that I may leave with my dog whether in day care, overnight boarding, or during a bath visit. 5. I agree that all photos and video footage taken of my dog while in the care of Four Paws may be used in advertising and marketing campaigns, website images and other uses for promoting the services of Four Paws. 6. I agree that, in the event my dog appears to be ill, injured or at significant risk of experiencing a medical problem, Four Paws, in its sole discretion, may seek veterinary care of its choosing on my behalf and that I will be responsible for all expenses.
